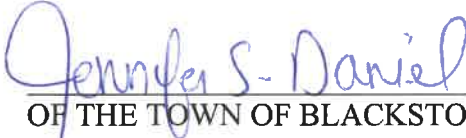
There being no further business to bring before Council, Mayor Green declared this Special Called Meeting adjourned at 7:06 p.m.
